
## Gear Box Removal

- 1. Begin Disassembly by removing the indicator flag (A). Loosen the indicator flag set screw (B) just below the indicator flag with a torx driver.
- 2. Use a small flat head screwdriver to pry indicator flag (A) off of shaft (C). This will allow for gear box removal.
- Using a 1/2" ratchet wrench loosen the three gear box bolts (D) on the bottom of the gear box (E).
- 4. Remove gear box (E).
















## Gear Box Installation

- 5. Install new gear box (F) making sure to align the gear box indentation (G) with the shaft key.
- Using a 1/2" ratchet wrench reinstall the three gear box bolts 6. (H) on the bottom of the gear box (F).
- Install indicator flag (I) 7.
- Tighten the indicator flag set screw (J) just below the 8. indicator flag (I) with a torx driver.









Note: Make sure the split washers are on the gear box retaining bolts before installing.
